REGISTRATION

To simply view the transitionmentoring.org Website, you are not required to register an account. However, your use is restricted to solely viewing limited portions of this Website. To use the full functionality of this Website, posting comments or reviews on the Website (at the Organization's discretion), you must first complete the registration form and create a user name and password. Your user name will be visible on all

postings that you make on the Website. During registration, you are required to provide contact information (such as name and email address), as well as demographic information. USE OF COOKIES ON TRANSITION MENTORING WEBSITE

“Cookies” are small files placed on your computer by our site that are used by your browser. Our site uses cookies to speed up the navigation process, keep track of items, and provide you with website tailored content. We also use cookies to remember information you gave us so you don’t have to re-enter it each time you visit Transition Mentoring website. By showing us how and when visitors use our site, cookies also help us see which areas are popular and which are not. Many improvements and updates to our site are based on the data derived from these cookies, such as total number of visitors and pages viewed. Most browsers are initially set to accept cookies.
